

# Reprofiling Rules 2017 Reprofiling Service

[March] 2017



#### 1 Introduction

These are the Reprofiling Rules applicable to the 2017 Reprofiling Service offered under paragraph 9 of Section B of the IUK Access Code (Issue 4) and these rules apply in addition to the IUK Access Code.

# 2 Eligible IAA Shippers

Only IAA Shippers that have been allocated Annual Capacity Products for any Gas Year in the Capacity Auction held in [March] 2017 (Eligible IAA Shippers) may make an application under paragraph 4 to use the Reprofiling Service.

# 3 Reprofiling Window

The Reprofiling Window during which Eligible IAA Shippers may apply to use the Reprofiling Service is from [xx:xx] hours on [xxxx] [March] 2017 to [xx:xx] hours on [xxxx] [March] 2017 or such other dates as IUK shall notify.

## 4 Application and Deadline

- (a) An Eligible IAA Shipper may apply within the Reprofiling Window to release to IUK eligible Registered Capacity.
- (b) Eligible Registered Capacity is an amount of Entry Capacity at any Entry Point or Exit Capacity at any Exit Point that is allocated as an Annual Capacity Product in the [March] 2017 Capacity Auction.
- (c) Such application must comply with these Rules (in particular paragraph 5) and with paragraph 9 of Section B of the IAC.
- (d) An Eligible IAA Shipper may make an application by completing the form in the Annex and submitting it to: [address/contact details].
- (e) Where an Eligible IAA Shipper wishes to make an application for the Reprofiling Service and for a conversion right under the Simplification Conversion Service in respect of the same Entry Capacity and/or Exit Capacity such Eligible IAA Shipper shall submit a single application that complies with these Reprofiling Rules and the SCS Rules, the form of which is set out in the SCS Rules.
- (f) The application for the conversion right under the Simplification Conversion Service will be made in respect of the adjusted amount of Entry Capacity or Exit Capacity (after the deduction of Released Capacity) where IUK accepts an application under the Reprofiling Service in respect of Eligible Entry Capacity and/or Eligible Exit Capacity.
- (g) Any application made is binding on the IAA Shipper and may not be withdrawn or changed without the prior written consent of IUK.
- (h) Eligible IAA Shippers must complete and send to IUK their applications by no later than the end of the Reprofiling Window.



## 5 Conditions

- (a) An Eligible IAA Shipper shall apply to release of an amount of Entry Capacity or an amount of Exit Capacity in respect of any Gas Year for which it is allocated an Annual Capacity Product in the [March] 2017 Capacity Auction;
- (b) The amount of Entry Capacity or Exit Capacity in a Gas Year applied to be released under paragraph (a) must not be greater than fifty percent (50%) of Entry Capacity or Exit Capacity in aggregate allocated for that Gas Year in the [March] 2017 Capacity Auction.
- (c) An Eligible IAA Shipper shall when making an application under paragraph (a) either specify the amount of Entry Capacity or Exit Capacity to be released for each Month in a Gas Year;
- (d) Where an Eligible IAA Shipper specifies the amount of Entry Capacity or Exit Capacity to be released for each Month in a Gas Year:
  - (i) subject to paragraph (b), there is no limit on the amount of Entry Capacity or Exit Capacity that may be released for each Month in that Gas Year; and
  - (ii) for at least three (3) Months in such Gas Year the Entry Capacity or Exit Capacity retained for each of those three (3) Months must be equal to the amount of the aggregate Entry Capacity or aggregate Exit Capacity for that Gas Year as allocated in the [March] 2017 Capacity Auction divided by 12;
- (e) An Eligible IAA Shipper is not liable to pay a Reprofiling Charge for the Reprofiling Service.

## 6 Acceptance and Notification

- (a) IUK has the right to reject any application as provided in paragraph 9.4 of Section B of the IUK Access Code.
- (b) IUK will notify an Eligible IAA Shipper whether it has been successful in its application and shall confirm to the IAA Shipper the amount of Entry Capacity and/or Exit Capacity that is Released Capacity for a Gas Year and the IAA Shipper's adjusted Registered Capacity for that Gas Year.



#### **ANNEX**

#### APPLICATION FOR REPROFILING SERVICE

To: Interconnector (UK) Limited

- 1. We refer to the [March] 2017 Reprofiling Service which IUK has offered to Eligible IAA Shippers to release Entry Capacity and/or Exit Capacity allocated as Annual Capacity Product(s) in the [March] 2017 Capacity Auction and the [March] 2017 Reprofiling Rules.
- 2. We are party to an IUK Access Agreement (IAA) with Interconnector (UK) Limited dated .
- 3. We agree that this application comprises the terms set out in paragraphs 1 to 9 and the completed tables set out in the Annex. We have read and understood: (a) the 2017 Reprofiling Rules; (b) Issue 4 of the IUK Access Agreement and the IUK Access Code (IAC); and (c) this application and agree that all such documents, as may be modified or replaced, govern this application.
- 4. In consideration of IUK offering the Reprofiling Service, we make an irrevocable and binding application for the release to IUK of the amounts of Entry Capacity and/ or Exit Capacity allocated in the [March] 2017 Capacity Auction as specified in the table(s) in the Annex below.
- 5. We agree, in connection with this application, that:
  - (a) IUK will assess all applications under the 2017 Reprofiling Rules and may reject any application that does not meet the requirements of these rules or paragraph 9 of Section B of the IAC;
  - (b) where, pursuant to this application, IUK accepts the release of Entry Capacity and/or Exit Capacity, that the release of such Capacity will be binding on us; the Capacity Transaction under which the Annual Capacity Product was allocated will be amended and paragraph 11.2 of Section B of the IAC shall apply.
- 6. We have the power and authority and have obtained all necessary governing body and shareholder approvals to make this application.
- 7. We acknowledge that this application constitutes Confidential Information under Clause 9 of Appendix A to the IAA and that the obligations under that clause apply to this application
- 8. We agree that Clauses 12.11, 13, 14 and 15 of Appendix A to the IAA apply to this application.
- 9. Capitalised terms not defined in this application shall have the meaning given to them in the IAA or IAC. Cross references to clauses of the IAA or paragraphs or sections of the IAC shall be to such clauses, paragraphs or sections as may be re-numbered or modified.
